This Licence – Cum – Technology Transfer Agreement ("Agreement") made on this the 20th day of May in the year 2021 ("Effective Date"):

By and Between: M/s Technotronics Global Security Solution Pvt Ltd , a company incorporated under the provisions of the Companies Act/a Start-up registered , in the year 2016 with Corporate Identity Number U72300MH2016PTC272899 having its registered office at G167, APMC market, Sector 18, Turbhe,Navi Mumbai 400703 and factory address at Unit no 56, 3rd floor GAMI INDUSTRIAL PARK, PAWNE,TURBHE MIDC, Pin code 400705, represented herein by its <u>CEO</u>, Vijay Chaudhari (hereinafter referred to as **THE LICENSEE** which expression shall, wherever the context so requires or admits, mean and include its successors-in-interest, administrators, legal representatives and executors), of the ONE PART

And:

The President of India, acting through Department of Space and herein represented by the DIRECTOR, VIKRAM SARABHAI SPACE CENTRE, INDIAN SPACE RESEARCH ORGANISATION, having its address at Thumba PO, Thiruvananthapuram 695 022, (hereinafter referred to as **THE LICENSOR**, which expression/s shall wherever the context so requires or admits, mean and include its successors-in-interest, administrators, legal representatives and executors), of the OTHER PART.

The Licensee and the Licensor, where the context may require, shall be individually referred to as a "Party" and collectively as the "Parties".

1. PREAMBLE:

- 1.1. WHEREAS VSSC/ISRO is a premier space research and technology organization in India and is responsible for the development of space technology and its application for national tasks; and has developed a portable Medical Oxygen Concentrator (MOC) named 'SHWAAS' (शार), which meets the specifications as required by WHO and which can continuously deliver enriched level (>82%) of oxygen than in air to support patients with respiratory illness or who are on oxygen therapy, specifically for societal applications;
- 1.2. VSSC, ISRO is now offering to transfer this technology to competent Indian Industries on non-exclusive basis to establish Medical Oxygen Concentrator (MOC) named 'SHWAAS' (웹대) production facilities in the country that can produce Medical Oxygen Concentrators catering to meet the need of the country in this pandemic situation caused by Covid-19 (hereinafter referred to as 'technology transfer').

Now accordingly this MoA agreement witnesses that, it is hereby agreed by and between the parties that the technology transfer of MEDICAL OXYGEN CONCENTRATOR shall be used for the manufacture of MEDICAL OXYGEN CONCENTRATOR in India only, on terms and conditions hereinafter contained below:

2. TRANSFER OF TECHNOLOGY

- 2.1. ISRO shall transfer the in-house developed technical knowhow and procedure for realisation of MEDICAL OXYGEN CONCENTRATOR as per Annexure-1 through a set of process document (hereinafter referred to as 'Technology Transfer Document (TTD)'). The TTD shall contain the technical specifications and procedure for realisation of MEDICAL OXYGEN CONCENTRATOR detailing all processes, specifications and sources of raw materials, etc for making MEDICAL OXYGEN CONCENTRATOR.
- 2.2. Industry shall not transfer the technology obtained from ISRO under this agreement by resale or otherwise to any other party, in any manner.
- 2.3. ISRO does not assure any kind of buy-back of products/ services/ usage of facilities under this Agreement at any point of time.
- 2.4. Within 4 (four) months of the effective date of this Agreement, the Licensee shall establish manufacturing/ and testing facilities at its premises as per the specifications as may be required / instructed by the Licensor.
- 2.5. The Licensee agrees that time is of essence of this Agreement and Licensee shall strive for successful production and commercialization of the 'SHWAAS' within 4 months from the receipt of TTD from Licensor but in any case, not later than 9 months.
- 2.6. 'SHWAAS', being a medical equipment, the Licensee shall take necessary certification/approvals/license from the concerned government authorities for the sale of 'SHWAAS' before its human use.
- 2.7. The Licensee shall offer subsequent 'SHWAAS' manufactured by the Licensee for inspection by the Licensor, as and when the Licensor so desires.

3 FINANCIAL ARRANGEMENTS

No TT Fee/Royalty shall be paid by the Licensee to the Licensor for the transfer of technology of 'SHWAAS' under this agreement.

4 TECHNICAL CONSULTANCY

Ki

ISRO shall extent its best efforts in supporting through technical advices during the realisation phase of MEDICAL OXYGEN CONCENTRATOR, at the request of the Industry in resolving technical bottlenecks raised by the Industry for a period of two months from the signing of this agreement.

5 INTELLECTUAL PROPERTY RIGHTS

All intellectual property rights relating to MEDICAL OXYGEN CONCENTRATOR technology licensed by ISRO vests with ISRO.

Notwithstanding anything contained in this technology transfer agreement all the civil and commercial rights including intellectual property rights connected with the technology under transfer shall not be used, further transferred or applied by third solut party.

6 CONFIDENTIALITY

Industry guarantees that the technical information and data acquired from ISRO during the implementation of this Agreement will be treated as confidential and will not be divulged to any third party or otherwise made public without the prior written permission of ISRO. This would apply even after Industry validity period as per clause 12 is over and there shall be no time limit for the maintenance of confidentiality. This provision shall not however apply to technical information and data which are part of the public domain as on the effective date of this Agreement.

7 INDEMNIFICATION

To the best knowledge of ISRO, the technology, covered under this Agreement is suitable for its intended use. ISRO shall not be responsible for any claims for damages or loss incurred by the Industry or customers or users of the Medical Oxygen Concentrator under any circumstances based on the technology transfer, whatsoever.

8 DISPUTE SETTLEMENT MECHANISIM AND JURISDICTION

In event of any dispute or difference of opinion between the Parties hereto, such disputes and differences shall be resolved amicably by mutual consultation. Failing which the party with the written consent of the other party may take recourse of any alternative dispute settlement mechanism including arbitration to settle under provisions of the Arbitration and Conciliation Act, 1996 and other applicable laws. The place of arbitration and jurisdiction for the other civil proceedings shall be preferred at Thiruvananthapuram.

9 FORCE MAJEURE

Neither ISRO nor the Industry shall be liable to the other for any delay in or failure of its obligations under this Agreement caused by occurrences beyond the control of ISRO or the Industry (as the case may be) including fire, floods, acts of God, acts of the public enemy, wars, insurrection, riots, strikes, lockouts, sabotage, any law statute or ordinance order, action or regulations of the Government or any compliance therewith similar to the above. Either party shall promptly, but not later than thirty (30) days thereafter notify the other of the commencement and cessation of such contingency and if such contingency continues beyond six (6) months, both parties may mutually agree to discuss and agree upon an equitable solution for termination of this Agreement or otherwise decide the course of action to be adopted. The respective obligations of parties shall be extended for the period of Force Majeure provided notices as required above are given in time and the contingency if required so is established by the other party. The Parties also hereby agree that notwithstanding what is contained in this clause, each of them shall infuse such effort as may be reasonably necessary to reverse such Force Majeure situation as early as possible, so that that the operation of this Agreement is restored. In the event of foreen

majeure, if ISRO or Industry is unable to comply with its responsibilities, the parties shall not be held liable for any failure or delay in performance of its obligations hereunder for the duration of the period of force majeure conditions prevailing.

10 AMENDMENTS

No amendment/ or modification or /alteration of any of the terms or provisions of this agreement shall be valid till it is reduced to writing and duly signed by both the parties. Any amendment of financial/commercial nature shall be subject to final approval by Director, VSSC.

11 EFFECTIVE DATE OF THE AGREEMENT

This Agreement shall be effective on and from the date of it is signed by both the parties.

12 DURATION OF THE AGREEMENT

- 12.1.The Agreement shall remain in force until it is terminated herein provided or until its cessation upon the expiry of TWO YEARS whichever is earlier in time from the date of signing of this Agreement.
- 12.2. In the event of cessation of this Agreement on the expiry of two years from the date of signing of this Agreement or earlier termination, both Parties shall be relieved of their obligations under this Agreement except clause 6 and clause 8.

13 EXERCISING AUTHORITY

Any/all instructions or notices which are to be given to and for any/all acts authorised or required to be done under or in consequence of these conditions by ISRO may be done by Director, VSSC or his nominee. The exercising authority in the case of INDUSTRY shall be the TECHNOTRONICS GLOBAL SECURITY SOLUTION PVT LTD or his nominee.


